UIL Region 11 Marching Contest Entry Procedures FAQs

Q: How much is the entry fee for the UIL Region 11 Marching Contest?

A: The entry fee for UIL Music Region 11 Marching Contest is \$475.00.

Q: What methods of fee payment are accepted?

A: We accept a district, school, booster club, and/or personal check or a money order. We cannot accept cash or school district purchase orders. <u>Please make checks/money orders payable to UIL Music Region 11.</u>

Q: What is required to enter the UIL Region 11 Marching Contest?

- A: 1. Register your school in Texas Music Forms at <u>www.texasmuscforms.com</u>.
 - 2. Enter your band in the appropriate contest in Texas Music Forms as directed.
 - 3. If it's your classification's year to participate in Area Marching Contest and you intend to participate if all criteria for advancement is met, check the Area Marching Contest box on TMF. *No Letter of Intent form is necessary if you select the option to advance to Area MC on TMF.*
 - 4. Access, print, and mail Form 1A Contest Fee Invoice from TMF to UIL Music Region 11.
 - 5. Mail Statement of Compliance* to UIL Music Region11.
 - 6. Mail Contest Announcer Script* to UIL Music Region11.
 - 7. Mail entry fee check/money order to UIL Music Region 11.

Form 1 "ELIGIBILITY/CERTIFICATION FORM" (*not the same as Form 1A!*) from Texas Music Forms can be mailed/delivered to the Executive Secretary *on or before* the day of the contest. It **DOES NOT** need to be sent with your other forms even though Texas Music Forms indicates that you must. However, Form 1 "ELIGIBILITY/CERTIFICATION FORM" must be turned in to the Executive Secretary *before* your band can perform. If your Form 1 "ELIGIBILITY/CERTIFICATION FORM" is not turned in prior to your band's performance, your band will be allowed to perform; however, all ratings and related awards will be held until the form is received. The band director will receive a formal reprimand from the UIL Music Region 11 Executive Committee for failure to submit the required form by deadline.

Please print your Form 1 "ELIGIBILITY/CERTIFICATION FORM" on buff colored paper to help simplify our clerical/filingsystem. Let us know if you need this color of paper.

- **Q:** When are UIL marching entry fees/forms due?
- A: All fees and forms (*except* Form 1 "ELIGIBILITY/CERTIFICATION FORM") must be postmarked 30 days prior to the contest. Please refer to the UIL Region 11 website at <u>www.uilmusicregion11.com</u> under the CALENDAR tab. Click on the PDF UIL Region 11 Master Contest Schedule and Fees for all contest deadlines.
- **Q:** What happens if all required forms and fees *are not* received by the entry deadline?
- A: As approved by the UIL Music Region 11 Executive Committee, the \$50.00/\$100.00 late fee for each organization is described below:

Example 1: Entry Fee + \$50.00 (*Late Fee*) *if an entry is added up to 7 days prior to the contest.*

Example 2: Entry Fee + \$100.00 (*Late Fee*) *if an entry is added within 7 days of the contest.*

All late entries will be subject to a reprimand by the UIL Region 11 *Executive Committee.*
