

# UIL Region 11 Marching Contest

## Entry Procedures FAQs

Updated Aug 2020

**Q:** How much is the entry fee for the UIL Region 11 Marching Contest?

**A:** The entry fee for UIL Music Region 11 Marching Contest is **\$475.00**.

**Q:** What methods of fee payment are accepted?

**A:** We accept a district, school, booster club, and/or personal check or a money order. We cannot accept cash or school district purchase orders. Please make checks/money orders payable to UIL Music Region 11.

**Q:** What is required to enter the UIL Region 11 Marching Contest?

**A:** 1. Register your school in Texas Music Forms at [www.texasmusicforms.com](http://www.texasmusicforms.com).

2. Enter your band in the appropriate contest in Texas Music Forms as directed.

**Note changes effective 2020 MBC: Section 1105(j)(1) of the C&CR:** Any 2A/3A/4A/5A/6A varsity band that has followed the procedures established by the region executive committee to indicate to the region executive secretary the intent to advance to area and that receives a division 1 rating at the region contest shall be certified for advancement to the area contest.

**Section 1106(a) of the C&CR:** The area marching band contest will be held for conferences 6A, 5A, 4A, 3A, and 2A.

3. Mail Form 1A Contest Fee Invoice from TMF to UIL Music Region 11.

4. Mail Statement of Compliance\* to UIL Music Region 11.

5. Mail Contest Announcer Script\* to UIL Music Region 11.

6. Mail entry fee check/money order to UIL Music Region 11.

Under *Contest/Evaluation* click on *Marching*.

Form 1 “ELIGIBILITY/CERTIFICATION FORM” (**not the same as Form 1A!**) from Texas Music Forms can be mailed/delivered to the Executive Secretary **on or before** the day of the contest. It **DOES NOT** need to be sent with your other forms even though Texas Music Forms indicates that you must. However, Form 1 “ELIGIBILITY/CERTIFICATION FORM” must be turned in to the Executive Secretary **before** your band can perform. If your Form 1 “ELIGIBILITY/CERTIFICATION FORM” is not turned in prior to your band’s performance, your band will be allowed to perform; however, all ratings and related awards will be held until the form is received. The band director will receive a formal reprimand from the UIL Music Region 11 Executive Committee for failure to submit the required form by deadline.

**Q:** What happens if a director registers late, after the deadline date?

**A:** As approved by the UIL Music Region 11 Executive Committee, a \$50.00 late fee will be assessed.
